Description of the Defect :	When the emergency breakaway system pin is pulled and not replaced the electrical circuit is closed. When the small breakaway battery (CURT) is depleted, the emergency brake system draws through the charger from the main battery. The total assumed draw is around 10amps - 12 amps. The charger is rated around 5amps. This causes an overload which could lead to a fire.
