On August 10, 2020, KTM North America reported to KTM AG, the manufacture in Austria, of a customer service claim for damage to the wiring harness on a 2020 KTM 1290 Super Duke R. KTM AG Quality Control began an investigation of the condition on August 11, 2020. A second incident in Germany was reported to KTM AG Customer Service on August 26, 2020. After investigating the cause of the condition, KTM AG determined that an adjustment in the line assembly was required. On August 28, 2020, KTM AG determined that a recall should be conducted for all MY 2020 KTM Super Duke R units.

### **Description of Remedy :**

| Description of Remedy Program :                           | Official KTM dealers will inspect the wiring harness located in the rear<br>part of the motorcycle for damage and repair, if necessary. This work must<br>be performed by an authorized KTM Dealer and will be free of charge. |
