These units were

manufactured between 11/27/2019 thru 10/28/2020 using a different type of paint on the steering gearcase mount plates. This paint could flow and relax over time

causing the bolts to lose clamp load and loosen.

Description of the Defect: Loose steering gear mount bolts on Independent Front Suspensions

Description of the Safety Risk: The steering gear mounting fasteners could loosen and back out to the point

that they may interfere with other steering components. This may cause difficulty in steering or prevent steering to one direction which could increase

the risk of a crash.

Description of the Cause: Reyco Granning made a change to the type of paint used on the steering

gearcase mount plates. The new paint can continue to flow and relax over time,

despite

appearing to be cured. As the paint flows out from under the bolt head and

washer, the film thickness of the paint decreases. This flowing action allows the bolt stretch that was gained during the torqueing procedure to relax and clamp load is lost. Once loose, the bolts will continue to back out due to road

Identification of Any Warning The driver may notice a change in steering feel, primarily related to vagueness, that can Occur: difficulty in holding a straight line, or vehicle wandering, the fasteners may also loosen without warning.

On Feb 24, 2021, Adam Kuiken from Reyco Granning emailed Rosenbauer America alerting us of a recall on a limited amount of front suspensions that we purchased from them and were manufactured from 12/2019 to 09/2020. We informed our internal departments and cross referenced Reyco Granning's list with our own and located the trucks that are in WIP and in the field. We will work with Reyco Granning to obtain the replacement repair kits and coordinate the remedy with the dealers and Production floor personnel.

Description of Remedy:

Description of Remedy Program: Rosenbauer will contact affected customers and their dealer to inform

them of the recall. Rosenbauer will obtain the repair kit from Reyco Granning or will send Reyco Granning the appropriate information to ship to the kit to our dealer. The customer will schedule the repair with the dealer. At that time, we will ask the dealer and/or customer to alert Rosenbauer of that arrangement. The dealer will contact Rosenbauer for reimbursement of up to 1.5 hours. We will send the appropriate invoice information to Reyco Granning for reimbursement using our ticket tracking system to track parts and costs.

How Remedy Component Differs The remedy involves replacing the bolts and flat washers provided by from Recalled Component: Reyco Granning that hold the steering gear to the mounting plate with a new bolt and a serrated wedge locking washer. This bolt and washer combination has been tested extensively to ensure that proper clamp load is maintained even if the paint film thickness changes significantly.
