REASON FOR THIS COMMUNICATION

NOTE: This communication supersedes the Awareness Communication previously published under safety recall number 17S19.

To inform you that Ford Motor Company is notifying the National Highway Traffic Safety Administration (NHTSA) of a safety recall on the affected vehicles. Parts are not currently available to complete the required repair. Once NHTSA has been informed, there is a possibility that you may be contacted by customers about the recall. This notice will help you answer customer questions.

REASON FOR THIS SAFETY RECALL

NHTSA and Takata have determined that the propellant in certain Takata airbag inflators can experience an alteration over time with exposure to certain climate conditions. A combination of time, high temperature fluctuations, and humidity contribute to the degradation of the propellant in the inflators. This degradation can cause the propellant to burn too quickly, creating high pressure inside the inflator, and in extreme cases causing the inflator to rupture in the event of a crash necessitating airbag deployment. A ruptured inflator can send inflator parts toward vehicle occupants resulting in serious injury or death. Additional information regarding Takata recalls can be found at www.safercar.gov.

AFFECTED VEHICLES

NOTE: The vehicles affected by this upcoming safety recall were recalled under FSA 19S01 (or previously FSA 16S26, 17S01, or 18S01) for the passenger side airbag. This safety recall will involve the driver side airbag.

CUSTOMER NOTIFICATION

Owners of affected vehicles will not be notified until after dealers have received service repair and parts ordering information. It is anticipated that customer notification will begin April 1, 2021.

OASIS and FSA VIN Lists will be activated once the full dealer bulletin has been posted.
