On March 8, 2021, the Viking/Clipper Manufacturing plant notified Forest River's Office of Corporate Compliance ("OCC"), that during a routine Corporate Quality and Pre-Delivery Audit that the cooktop was missing a panel that seals the cooktop from the furnace cold air intake. OCC began an investigation and identified through production records that the panel had not been installed on any of the Viking or Clipper model 182DBU.

On March 12, 2021, Forest River's Corporate Committee Voted to recall
