




IMPORTANT SAFETY RECALL 2021060001

This notice applies to your vehicle, VIN: Check the Steering Shaft NHTSA Recall #21V229

July 2021



- A remedy is available for your vehicle.

Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2017-2018 CLA-Class, GLA-Class, and B-Class vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the C	CONCERN?	In certain MY 17-18 CLA-Class, GLA-Class, and B-Class vehicles, the steering shaft might not meet current production specifications, which may result in noises and an imprecise steering feel. Over time, this could result in separation of the universal joint bearing on the steering shaft, and a loss of steering control, which could increase the risk of a crash. Before this occurs, however, the driver may notice noises or an imprecise steering feel.								
What will you	Ir DEALER DO?	An authorized Mercedes-Benz dealer will check the steering shaft on the affected vehicles and replace it, if necessary. <u>This service will be provided free of charge.</u> We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be less than an hour and a half , your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of the normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time.

Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already paid to have this recall condition corrected, you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer. The following documentation must be presented to your dealer for reimbursement.

Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check or copy of credit card receipt).
- Reimbursement will be made by check from your dealer. If your claim is denied you will receive a letter from MBUSA within 60 days of receipt with the reason(s) for the denial.
