Chronology:

In July 2020, MBAG launched initial investigations based on field reports describing instances in which the side spoiler allegedly had detached from the vehicle during driving.

In September 2020, the investigations were extended to cover potential influences to a side spoiler detachment from the supplier production process, the vehicle series assembly process and the rework process.

As a short-term measure, an additional 100% push-pull check was introduced in mid-September 2020. In October 2020, the investigations indicated a correlation between reported cases from the field and certain rework measures in the vehicle assembly plant which included a removal and re-installation of the side spoilers. For further confirmation of these findings, the mounting of the side spoilers on vehicles that were accessible by the plant were checked and compared between vehicles with and without rework measures affecting the side spoiler.

Between December 2020 and February 2021, potentially affected vehicles in the field were identified based on the findings relating to the rework measures in the area of the side spoilers.

On March 26, 2021, MBAG determined that a safety risk cannot be ruled out and decided to implement a voluntary safety recall.

Description of Remedy:

Description of Remedy Program: An authorized Mercedes-Benz dealer will check the mounting of the side

spoilers and replace them, if necessary.

Pursuant to 49 C.F.R. § 577.11(e), MBUSA does not plan to provide notice about pre-notice reimbursement to owners since none of the involved vehicles would have been previously subject to the condition described

and all remain covered under the new vehicle warranty.
