Problem Description:

Spartan Fire, LLC (Spartan Fire) is recalling certain 2019-2021 Spartan Fire Gladiator and MetroStar vehicles. Pressure may build in the power steering pump and break the shaft seal, resulting in a loss of power steering assist.

Consequence:

A loss of power steering assist may increase the risk of a crash.

Remedy:

Spartan Fire will notify owners, and dealers will provide a new power steering pump, free of charge. The recall is expected to begin May 24, 2021. Owners may contact Spartan Fire customer service at 1-517-543-6400.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
