In February 2020, Spartan experienced an incident in production of loss of power steering assist. On February 23, 2020, it was determined at the time to be an infantile issue and road test caught failures before shipment. A PPS team was created to review the issue by engaging assembly, suppliers and engineering. On September 18, 2020, ZF confirmed root cause and began containment by measuring the cam and rotor 100% for flatness prior to assembly. On October 5, 2020, ZF made a process sequence change for a permanent corrective action. In March 2021, Received our first field claim with a similar failure mode. On March 31, 2021, the issue was escalated to REV Group management. On April 6, 2021, REV senior leadership recommends to submit a voluntary recall for this issue.
