May 22, 2021

#### Dear Cummins Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Cummins Inc. has decided that a defect which relates to motor vehicle safety exists in certain Cummins PowerDrive™ electric drivetrain systems that were manufactured between June 1, 2018 and February 23, 2021.

This notice applies to the PowerDrive electric drivetrain systems in your vehicle listed on the enclosed table.

#### WHAT IS THE PROBLEM?

The subject electric drivetrain systems may experience a condition that results in the loss of electrically assisted power steering. Power steering functionality is restored after a key switch recycle.

In the event of loss of power steering assist, manual steering functionality is retained but would require increased steering effort, particularly at lower speeds, increasing the risk of a crash.

### WHAT WILL CUMMINS DO?

Cummins is currently developing the permanent remedy for this issue. You will receive a second notification to inform you when the final remedy is available and to provide instructions to schedule the recall for your PowerDrive system.

#### WHAT SHOULD YOU DO?

No action is necessary until you receive a second notification from Cummins.

Also, it is a violation of Federal law for a dealer to deliver a new vehicle or equipment covered by this recall notice under a sale or lease until the defect has been remedied.
