Chronology:

August 24, 2020: Volkswagen AG Product Safety Committee requests VWGoA to provide an update on the results on the internal audit, following up on prior related audits focused on internal processes. In that meeting, VWGoA was requested to perform an independent audit of the factory analysis from the previous similar recalls (01C5, 01C6, 01D7). All vehicles with a certain production code that were produced/imported from MY 2010 or later were to be included in the audit.

September 2020-April 2021: Analysis ongoing, VWGoA contacted factory personnel, corporate vehicle custodians, Corporate Vehicle Services & other business partners to identify potentially affected vehicles and establish their status and disposition.

April 28, 2021: Topic was presented to Product Safety Committee of Volkswagen AG. Decision to repurchase vehicles identified in the VWGoA Internal Audit report. The recall decision was not based on a confirmed safety risk but was based on incomplete documentation confirming that the subject vehicles complied with applicable standards. Vehicles may or may not be repairable with replacement parts or existing software updates.
