**Subject:** Engine Cylinder Bore Surface May Develop Cracks

This letter serves to acknowledge Lamborghini (Automobili Lamborghini)'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. **Problem Description:**

Lamborghini (Automobili Lamborghini) is recalling certain 2021 Urus vehicles. Cracks may develop on the surface of the engine cylinder bore.

**Consequence:**

Cracks may cause engine damage and a stall or an oil leak, increasing the risk of a crash or fire.

**Remedy:**

Dealers will replace the engine, free of charge. Owner notification letters are expected to be mailed June 30, 2021. Owners may contact Lamborghini at 1-866-681-6276. Lamborghini's number for this recall is L636-R.03.21.

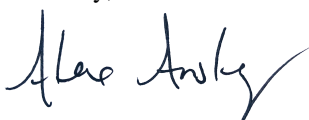
You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
