Description of the Defect : The Breakaway switch power lead is wired to the auxiliary side of the battery disconnect. Without constant power to the switch, it may not engage when needed and consequently not allow the trailer brakes to activate.

FMVSS 1 : NR

Description of the Safety Risk : If the battery disconnect is in the "off" position, the breakaway switch will not engage when needed, the trailer brakes will not activate which may lead to a crash resulting in property damage, injury and/or death.

Chronology :

On May 7, 2021, The manufacturing plant notified Forest River's Office of Corporate Compliance ("OCC") that the breakaway switch may not have been wired to the correct battery disconnect terminal.

On May 10, 2021, OCC opened an investigation with the manufacturing plant.

On May 12, 2021, OCC and the plant determined the wiring in question was isolated to a certain manufacturing schedule and ended on April 6, 2021. All vehicles in Forest River possession where inspected and remedied as needed.

On May 14, 2021, Forest River's Corporate Recall Committee voted to recall.

A-1 On July 20, 2021 filed an amendment to add the breakaway switch and battery disconnect to component

information as requested by NHTSA.

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor at no charge to the consumer. An authorized Forest River or Coachmen dealer or service center will need to perform the remedy. The remedy will include wiring the breakaway switch to the constant power lug to the battery disconnect.

How Remedy Component Differs from Recalled Component : The breakaway switch will now be wired to the correct constant power lug at the battery disconnect.

Identify How/When Recall Condition was Corrected in Production : The week of May 6, 2021 the manufacturing plant began wiring the breakaway switch to the correct constant power lug at the battery disconnect.

Recall Schedule :

Description of Recall Schedule : Forest River has the utmost urgency in our recalls. Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
