On April 29, 2021 an internal check has raised that all the first part of production of this specific bike model was assembled with the incorrect front and rear turn signals.

After that was defined that the turn signals were not meet certain requirements in FMVSS.

On May 11, 2021, Ducati Motor Holding's internal safety commission decided to launch a recall campaign to address this condition in the affected population.

Description of Remedy:

Description of Remedy Program: Ducati North America will notify dealers and owners of this recall in accordance with the notification schedule. Dealers will be instructed to install different front and rear turn signals, free of charge, per Ducati North America Recall Bulletins, which will be published to the Ducati Dealer Network using the established communication process.

Requests for reimbursement for pre-notification repairs will be considered in accordance with Ducati's general reimbursement plan on file with the agency.
