Description of the Defect :	The harness manufacturer installed the incorrect terminals within one side of the connectors, resulting in a male to male terminal connection where it should have been a male to female terminal connection. When the incorrect terminals are installed, this may cause a poor connection and the vehicle to not shift into pump mode when requested.
FMVSS 1 :	NR
FMVSS 2 :	NR
Description of the Safety Risk :	A poor connection at the terminals may cause the vehicle to not shift into pump mode when requested. This increases the risk of personal injury and equipment damage.
Description of the Cause :	The harness was manufactured with the incorrect terminals within one side of the pump shift solenoid connectors.

On April 16, 2021 - Customer notified Spartan of a couple claims regarding a pump shift harness issue. An Engineering team started investigation.

April 29, 2021 - A problem solving review team (PSR) was created.

April 29 – May 20, 2021 - Continued reviewing production, design, supplier parts, established containment and determined potential population.

May 21, 2021 - Risk assessment was completed.

May 21 – June 11, 2021 – Discussion with REV Group Product Compliance about the issue.

June 11, 2021 – The issue was escalated to REV Group Management.

June 15, 2021 - REV Group Management approved an involuntary recall for this issue.

Description of Remedy :

Description of Remedy Program :	Spartan will replace affected terminals on the harness at no cost. Vehicles that have been remedied would have been covered through the normal warranty process.
v 1	A new supplier is providing the pump shift harnesses for the S-180 vehicles as of November 2020. All inventory was verified correct on April 30, 2021.
