A-1 On 6/23/2021 During a Corporate Pre Delivery Inspection (PDI), it was found that the federal placard stated that six seatbelts were available for occupants. There are only four available. The same day the Manufacturing Plant contacted Forest River's Office of Corporate Compliance (OCC). It was determined that five vehicles had shipped from the manufacturing plant.

On 6/25/2021, Forest River's Corporate Recall Committee voted to recall.

On July 20, 2021 amended recall to reflect the safety risk and year of chronology clerical error as per NHTSA's request $\frac{1}{2}$
