This letter serves to acknowledge Forest River, Inc.'s notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Forest River, Inc. (Forest River) is recalling certain 2021 Prime Time Tracer TRT22RBS recreational trailers. The tail light is located too close to the water heater exhaust, which may cause the tail light to become distorted and fail.

Consequence:

A distorted or inoperative lens can reduce trailer visibility for other drivers, increasing the risk of a crash.

Remedy

Dealers will install a new water heater, and replace the tail light if necessary, free of charge. Owner notification letters are expected to be mailed September 6, 2021. Owners may contact Forest River customer service at 1574-862-1025. Forest River's number for this recall is 51-1389.

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of six consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
