certain vehicle starting conditions, the LCD screen will remain blank resulting in the driver's inability to see the odometer. As a result, the subject vehicles fail to comply with the visibility requirements of Federal Motor Vehicle Safety Standard 101, §S5.1.2. This condition does not affect the functionality of the
