We received a complaint from Transport Canada on Monday 8/2/2021 regarding a customer with a T233 model unit who had experienced the tank brackets fail on his unit. The bracket appeared to only have a single self-lag securing the bracket on each side and was built during the same time frame of the recalled units for 20V482. Upon further investigation it was found that other models and units were within the time frame of 20V482 and should have been included in the original recall but were missed.

On 8/6/2021 Forest Rivers Corporate Recall Committee voted to recall.

Description of Remedy:
