has determined that on certain Model Year ("MY") 2020 GLB-Class (247 platform) vehicles, the airbag control unit software might not meet current

production specifications.

Description of the Safety Risk: The activation timing of the seat belt force limiters (driver and front

passenger seats) and the front passenger airbag might deviate from their specifications. Thus, in the event of a frontal collision with activation of the restraint systems, the risk of injury for the occupants might increase.

Chronology:

In mid of September 2019, MBAG launched its initial investigations based on feedback from the vehicle plant that vehicles may have left the plant with an incorrect parameter data set on the airbag control unit. The installed parameter data set originates from a different vehicle model and includes slightly different activation timing of the restraint system. From October 2019 onwards, the parameter data sets were initially compared to identify and evaluate possible differences.

From March to June 2020, MBAG operations were severely restricted due to the COVID-19 pandemic. As operations began to resume in June 2020, MBAG conducted evaluations to identify potential effects of the different parameter data set and activation timing on the restraint system in various load cases. That testing and evaluation continued into 2021.

From February 2021 onwards, investigations were conducted concerning the occupant restraint effects as well as the occupant load values in the event of a frontal impact. In parallel, regulatory compliance in the potentially affected markets was analyzed. On August 6, 2021, MBAG determined that a potential safety risk cannot be ruled out and decided to conduct a recall.
