Swab Wagon Company was notified by NHTSA on August 16th, 2021, that we had purchased and installed lighting from Code 3 that was noncompliant with FMVSS 108, and are required to conduct a formal recall to notify the owners of those vehicles. None of our customers filed warranty claims. On August 26, 2021, we proactively sent out filter kits provided to us by Code 3, Inc., free of charge, to our customers with the affected lighting equipment, which included instructions to the customer on how to properly install the filter kit. We have not been notified of any injuries or deaths associated with this noncompliant lighting equipment.
