An IMPORTANT SAFETY RECALL (21E-047) notice was sent by Lippert Components, Inc. to Coach House, Inc. on or about 7/2/2021.

On 8/24/21 a telephonic conference was had between Tom Molay (Warranty Administrator - Coach House, Inc.) and Pamela Vandermel (Director of Warranty - Lippert Components, Inc.) and Bobby Bradley (Lippert Components, Inc.)

During the phone conference it was determined that only the 20" x 30" Exit Window was involved in this recall as it pertains to Coach House, Inc. Other windows are "non-vented" and not under this recall.
