Description of the basis for the determination of the recall population:

The recall population was determined based on supplier and manufacturing records.

Description of how the vehicles being recalled differ from similar vehicles not included in the recall:

According to tire noncompliance notification 21T-012 filed by Bridgestone Americas Tire Operations, LLC (BATO), a total of 7,739 potentially affected tires with the following tire identification numbers were manufactured:

Of the 7,739 potentially affected tires, 6,064 were shipped to Honda and supplier production records confirm that only seven of these tires contain the defect. Six of the seven tires were identified by Honda prior to the retail distribution of vehicles equipped with the affected tires. The vendor responsible for wheel assembly (wheel, tire, and TPMS) maintained records for the tire DOT code during receiving, and separately the TPMS ID number during assembly. These records indicate that the remaining individual tire with pinhole damage was included in a single lot of wheel assemblies that were shipped to Honda. The wheel assembly lot is designated for 270 vehicles, of which 181 vehicles were distributed for retail before the tires were inspected for pinhole damage.

Noncompliance description:

According to tire noncompliance notification 21T-012 filed by BATO, the tires may not meet the performance requirements in S6 of Federal Motor Vehicle Safety Standard No. 139, New Pneumatic Radial Tires for Light Vehicles. Affected tires containing a pinhole penetrating the tire inner liner may slowly leak air. If left unaddressed, this slow leak could affect tire performance and increase the risk of a crash.

Determination of noncompliance:

According to tire noncompliance notification 21T-012 filed by BATO, the technical investigation determined that the subject tires may not comply with the requirements of S6 of Federal Motor Vehicle Safety Standard No. 139, New Pneumatic Radial Tires for Light Vehicles.

Program for remedying the noncompliance:

Registered owners of all affected vehicles will be contacted by mail and asked to take their vehicle to an authorized Honda dealer. The dealer will inspect all four tires and replace the tire if a pinhole is found. If the one defective tire is found prior to owner notification mailing, Honda will abstain from owner notification and close the recall on the remaining vehicles as the sole defective tire has been identified.

Owners who have paid to have these repairs completed at their own expense will be eligible for reimbursement, in accord with the recall reimbursement plan on file with NHTSA.
