Problem was found on 9/28/2021 while trouble shooting a separate issue. The electrical engineer noticed there was an outlet missing. Investigated and found problem with change of blueprint 5/26/20. From that time till now, the outlet was not being put in and wire not being connected. Notified Safety committee 10/4/2021. Safety committee voted 10/06/2021 to do recall.

wire. This will be done at no charge to the owner of coach. There is no plan for reimbursement of past issues because if there were any issues, it would

have been taken care of under Tiffin warranty.
