Foretravel's decision to file a recall is based on the testing and data supplied by Lippert. Any vehicle in our service center with a window that was showing signs of delaminating glass panels were replaced under warranty by Lippert.

#### **Description of Remedy :**

Description of Remedy Program :	The remedy program will involve inspecting the involved windows with a go/no-go gauge to determine if the seal has been compromised. If an issue is found Lippert will provide a replacement vent at no charge.
	The remedy component was produced with the improvements including increasing the bond strength between the two panes of glass through the use of an adhesive backed glass spacer and different secondary sealant.
	Foretravel has pulled the 6400 windows that were allocate to each vehicle and inspected each one. There are no current 6400 windows that were manufactured during the Lippert production dates October 1, 2018 - August 14,2020.
