10/8/2021 - The yard inventory units for Plant #8 are inspected and found with the same defect. These units are corrected.

10/14/2021 - Additional units are repaired at transportation yards. Further verifications indicate units potentially affected have been shipped to dealers.

10/15/2021 - A safety Committee review is held and determines a recall should be issued.
