in November of 2020. This defect could be present in all units.

Description of Defect:

Description of the Defect: Braun has decided that certain Wheelchair Accessible Vehicles (WAV)

manufactured on the Chevrolet Traverse SUV chassis were assembled with a screw and screw clip, intended to hold a plastic wheel well liner reinforcement shroud on the driver front wheel well, in close proximity to the aluminum transmission case. Overtime, wear to the transmission case could occur.

Description of the Safety Risk: If a leak to the transmission were to occur, it could progress to a loss of

engine propulsion, which could increase the risk of a crash. A transmission oil

leak in the presence of an ignition source may increase the risk of fire.

Description of the Cause: The screw and screw clip retaining the inner wheel well plastic shroud causing

interference to the transmission was not installed on development units Braun

used for durability testing.

Chronology:

On September 23, 2021, a certified Braun dealer serviced a customer vehicle and noted wear to the transmission case in the driver front wheel well and a transmission fluid leak. Photos were submitted to Braun through our online case management system.

The issue was reviewed during Braun's routine Corrective and Preventative Action Reporting on September 24, 2021.

On September 28, 2021, Braun inspected another customer unit on its premises and confirmed wear in the same location. No transmission leak was present.

On September 29, 2021, Braun initiated containment efforts. Inventory was inspected. One unit was found and remedy was performed.

On October 15, 2021, Braun decided to conduct a safety recall. Braun is not aware of any injuries or accidents related to this condition.

Description of Remedy:

Description of Remedy Program: Dealers will remove the screw and screw clip and replace with a nylon christmas tree style push rivet and inspect for signs of contact with transmission. Braun will reimburse dealers directly. Customers will not be charged.

How Remedy Component Differs NR from Recalled Component:

Identify How/When Recall Condition A revised manufacturing instruction was approved and published to was Corrected in Production: production on October 18, 2021. Note: No Chevrolet Traverses were modified between containment and update to production. If an owner of an affected BraunAbility vehicle had a repair performed, related to this recall,

prior to receiving this letter, they may be eligible to receive
