What We're Doing	MBUSA is conducting a voluntary recall. An authorized Mercedes-Benz Sprinter dealer will exchange the incorrectly mounted 3.5t brake discs and pads on the front axle for the correct version (5t) on the vehicle affected.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vans, has determined that on one Mercedes-Benz Sprinter vehicle, (platform 907 -VS30), the front axle was equipped with brake discs intended for a 3.5t GVWR Sprinter instead of the brake discs for a 5t GVWR Sprinter. The brake discs for vehicles with 3.5t Gross Vehicle Weight Rating (GWVR) are not designed to withstand the thermal load experienced by vehicles with 5t GVWR during multistop braking and downhill driving. For a vehicle equipped with the 3.5t GVWR under those special operating conditions, braking distance might increase in some instances, which could increase the risk of a crash. An authorized Mercedes-Benz Sprinter dealer will exchange the incorrectly mounted 3.5t brake discs and pads on the front axle for the correct version (5t) on the vehicle affected.

Prior to performing this Recall Campaign:

- Please check VMI to determine if the vehicle is involved in the Campaign and if it has been previously repaired.
- Please review the entire Recall Campaign bulletin and follow the repair procedure exactly as described.
