Descriptive Information: Chrysler provided a list of affected VINs to Jayco regarding their recall 21V-699. Jayco

matched those VINs to our production records. Chrysler informed us that this recall affected MY 2021 Ram ProMaster and Ram ProMaster City vehicles with suspect Automatic Locking Retractor (ALR) levers that may affect the ALR function of the seatbelt retractor. The suspect period began on February 17, 2021 when suspect retractors were introduced into vehicle production and ended on June 16, 2021 when the suspect retractors were no longer used in vehicle production. The vehicle population was determined by Chrysler through seatbelt retractor traceability records and vehicle production records. Similar vehicles not included in their recall were built with seatbelt retractors that did not contain a suspect ALR lever. Their total population for recall 21V-699 is 10,372. Chrysler estimates 1% of the

population contain the defect.

assembly can be used to tightly secure a child restraint system". Vehicles built

with suspect seatbelt retractors may not meet the requirement.

Description of the Safety Risk : Chrysler reported to Jayco that this noncompliance does not impact the

compliance or functionality of the seat belt assemblies with respect to their normal use by adult passengers or use of the LATCH system to secure child retraint seats. With child restraint seats for which the vehicle owner elects to use the seat belt to secure the child restraint seat instead of the LATCH system, if the seat belt is not lockable so that the seat belt assembly can be used to tightly secure the child restraint seat, there is an increased risk of

injury in a crash to the occupant of the child restraint seat.

Description of the Cause: Seatbelt retractors with suspect Automatic Locking Retractor (ALR) levers

were introduced into Chrysler production.

Chronology:

Chrysler reported that on August 13, 2021, three seatbelt retractors with out of specification ALR levers were tested in a Ram ProMaster vehicle. It was confirmed that one of the ALRs deactivated earlier that intended and may not meet the FMVSS 208 S7.1.1.5 requirement. On September 2, 2021, FCA US determined through the Vehicle Regulations Committee to conduct a voluntary safety recall of the affected vehicles. Chrysler notified Jayco by email on September 21, 2021 of their recall 21V-699.

On September 27, 2021 the Warranty Incident Review Committee (WIRC) discussed this incident and elevated to the Corrective and Preventive Action Committee (CPAC). On October 6, 2021 CPAC met and decided to

elevate the incident to the Safety Steering Committee (SSC). The SSC met and discussed the incident on November 11, 2021 and voted to proceed with a pass through Jayco Motorized chassis recall.

Description of Remedy:

Description of Remedy Program: Chrysler reported that FCA US will inspect and replace seatbelt retractors

as needed on all affected vehicles.

Recall completion rate quarterly reports will be submitted by FCA US.

How Remedy Component Differs Chrysler reported that the remedy component will be a seatbelt retractor
