On Sep 29, 2021 DTNA was made aware of a potential tire rim mismatch. DTNA promptly began an investigation, in which it was found that the Tire and Rim Association had made changes to the approved wheel list for certain tires, removing certain combinations. Upon determining the existence of a noncompliance, on Nov 10, 2021 DTNA decided to conduct a non-compliance recall. On Nov 22, 2021, with further information, DTNA amended the affected population.

Vehicles with suspect tire/rim combinations will be replaced with tires approved for this tire/rim combination. Replacements will be made by Daimler Truck North America authorized service facilities. Details of the reimbursement plan will be included in the owner's notification letter.
