This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Autocar, LLC has determined that a defect, which relates to motor vehicle safety, exists in 251, 2021-2022 model year Xpeditor chassis manufactured between November 2, 2020, and June 16, 2021, with non-sequential serial numbers between 234753 and 236329. Our records indicate that your vehicle was manufactured within this time period and may contain the defect described herein.
