11.15.2021 The manufacturing GM report included 2 vehicles with unsealed generator compartment. Forest River's Office of Corporate Compliance (OCC) began an initial investigation into the matter.

11.19.2021 OCC presented the information from the GM report to the Corporate Recall Committee (CRC). The Committee decided to have vehicles in the field inspected to determine if the compartment was sealed. OCC instructed the manufacturing division to contact dealerships and inspect for the sealant.

12.15.21 The manufacturing division communicated to OCC that the field study was completed and a single vehicle failed the inspection.

12.17.21 Forest River's Corporate Recall Committee voted to recall
