**Descriptive Information :** The recall population was determined following discussions with NHTSA staff and a review of internal sales records. All Marainbow Portable Infant Safe Seats, as well as materially similar products which may suffer from the noted defects, are included in the recall. Materially similar products include: Portable Baby Infant Safe Seat Cover Baby Safety Convertible Car Seat; Portable Baby Infant Safe Seat Kids Car Seat; Thickened Portable Safety Car Seat for Children Aged 0-6; YDx Children Car Seat Breathable Adjustable Sandwich Mesh Anti-Slip Kids Safety Cushion; Portable Cartoon Kids Safety Car Seat Children Chairs Updated Version Thickening Baby Stroller Cushion; Pretty Comy Portable Cartoon Child Safety Car Seat Child Chair Updated Version Thickening Stroller Car Seat Cushion; QCTime Children Car Seat Breathable Adjustable Sandwich Mesh Anti-Slip Kids Safety Cushion; Child Car Seat Portable Folding Removable Waterproof Car Safe Seat; Twowood Children Car Seat Breathable Adjustable Sandwich Mesh Anti-Slip Kids Safety Cushion; Pretty Comy Portable Baby Infant Safe Seat Cover Childrens Chair Kids Car Seats Baby Safety Convertible Car Seat – Gray; Baby Safe Seat Infant Seat Cover Portable Baby Safety Seat Children's Chairs Kids Car Seats for Travel; Twowood Car Seat Comfortable Rust-Proof Car Supplies Booster Car Seat, and Farfi Car Seat Comfortable Rust-Proof Car Supplies Booster Car Seat. **Description of Noncompliance :**

Description of the Noncompliance : According to a letter dated December 1, 2020, NHTSA determined that the Marainbow Portable Infant Safe Seat child restraint system contains deficiencies which "constitute possible noncompliance with FMVSS No. 213 S5.3.1 (a), S5.3.2, S5.5, S5.6, S5.8, S5.9, and failure to file in accordance with 49 C.F.R. Part 566 and 49 C.F.R. Part 551."

FMVSS 1 : 213 - Child restraint systems

FMVSS 2 : NR

Description of the Safety Risk : The noted noncompliance does not affect the dynamic performance of the child restraints but the products may not have the required labeling as specified in S5.5, printed instructions as required by S5.6 or the product registration card as required by S5.8. The failure to provide the required information could result in caregivers using the CRS inappropriately and the failure to provide a mechanism for customers to register the CRS with a manufacturer increases the difficulty of locating customers in the event of a recall. Further, these child restraint systems were designed to be attached to the back and/or cushion which fails the requirements listed in S5.3.1 (a). The CRS also lacks the ability to be installed using the methods required by S5.3.2 & S5.9 for a CRS of this type. Failure to comply with these safety standards may result in improper installation and increase the risk of injury.

JD E-Commerce America Limited (“Joybuy Express”) received a cease and desist letter from NHTSA on May 3, 2022. On May 16, 2022, Joybuy Express confirmed that it ceased offers for sale in the United States of the products identified in NHTSA letter. On July 1, 2022, Joybuy Express agreed to conduct a voluntary recall. On December 29, 2022, Joybuy Express submitted a 573 Report to officially begin carrying out Recall No. 22C008.
