IMPORTANT SAFETY RECALL

Steering Gear

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that a defect, which relates to motor vehicle safety, exists in certain steering gear assemblies part numbers 68524908AA, 68524926AA and 68572913AA.

It is extremely important to take steps now to repair your vehicle to ensure the safety of you and your passengers.

WHY DOES MY ITEM OF EQUIPMENT NEED REPAIRS?

FCA US records indicate that you may have purchased a replacement steering gear assembly for your vehicle ^[1]. The steering gear assembly may have been built with a rack bar manufactured with hardness below specification that may bend or yield in certain circumstances. If the rack bar yields, it could bind within the steering rack, possibly resulting in sudden greater effort required to maintain directional steering control and/or the inability to maintain directional steering control, which can cause a vehicle crash without prior warning.

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

FCA US will repair your steering gear ^[2] free of charge (parts and labor). To do this, return an uninstalled steering gear assembly to your dealer for exchange. If the steering gear has been installed, your dealer will replace the steering gear in-vehicle. The estimated repair time for installed steering gear assemblies is 8 hours. In addition, your dealer will require your vehicle for proper check-in, preparation, and check-out during your visit. We recommend that you schedule a service appointment after May 27, 2022 to minimize your inconvenience. Please bring this letter with you to your dealership.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?
