December 2021: NHTSA requested information from Streamline regarding results from the Agency's compliance testing.

Jan. – Mar 2022: Streamline responded to NHTSA information request and internally investigated records related to brake hoses manufactured for on-road use.

Mar. 23, 2022: Streamline determined that a population of brake hoses intended for on-road use may not have been marked in accordance with FMVSS 106 S5.2.4.

### Description of Remedy :

Description of Remedy Program : Streamline will provide a band with the labeling information required in FMVSS 106 S5.2.4 or replace subject brake with brake hoses manufactured with the markings required by FMVSS 106 S5.2.4.

How Remedy Component Differs from Recalled Component :

The remedy component will include the required FMVSS 106 S5.2.4 band.

Identify How/When Recall Condition was Corrected in Production :

Based on current information, Streamline brake hoses manufactured for on-road motorcycles after 05/01/2020 were produced with the required labeling information.
