Descriptive Information: This recall includes tri-fold tonneau covers intended for 2019 – 2022 model year

1500 and 2500/3500 series models of Chevrolet Silverado and GMC Sierra trucks. The suspect Tonneau covers were identified through over-the-counter

sales records.

### **Description of Defect:**

Description of the Defect: This is an expansion of NHTSA Equipment Recalls 19E066 and 20E024.

General Motors has decided that a defect which relates to motor vehicle safety exists in certain tri-fold tonneau covers that may have been sold as over-the-counter accessories for 2019-2022 model year Chevrolet Silverado and GMC Sierra trucks. The tonneau cover may become loose and could detach from the

pickup bed while driving.

FMVSS 1: NR FMVSS 2: NR Description of the Safety Risk: If the tonneau cover detaches from a moving vehicle and falls into a roadway,

it may increase the risk of a crash.

Description of the Cause: The hard tri-fold tonneau cover's attachment system may not sufficiently

secure the tonneau cover to the truck bed rails if the attachment system is damaged or improperly installed. The soft tri-fold may become loose and detach from the vehicle if not correctly installed according to the instructions

provided with the vehicle in an owner's manual insert.

Identification of Any Warning If the tonneau cover is improperly installed, owners may notice noise coming

that can Occur: from the cover, damage to cover attachments, or cover movement against the

truck's bed rails.

## **Chronology:**

On January 28, 2022, a GM Canada engineer submitted a Speak Up For Safety report based on a customer complaint and a follow-up inquiry from Transport Canada. The inquiry related to a field complaint alleging that a tri-fold soft tonneau that GM previously recalled in Canada and the U.S. (NHTSA Recall 19E066) flew off the vehicle while driving. The vehicle involved in the incident was not identified as part of the previous recall population in Canada although the subject tonneau cover was a recalled part. On February 3, 2022, GM opened a product investigation to assess the scope of NHTSA Recalls 19E066 (soft tri-fold tonneau covers) and 20E024 (hard tri-fold tonneau covers).

GM's investigation conducted a supplemental analysis of U.S. and Canada part-sales records, and identified a number of additional VINs that may have received one of the recalled tonneau covers as an over-the-counter accessory. GM's investigation also identified a population of recalled tonneau covers that, because of an internal parts classification and tracking error, may have been incorrectly reintroduced into saleable service stock. On March 24, 2022, GM's Safety Field Action Decision Authority (SFADA) decided to expand the prior equipment recalls to inspect and, if necessary, perform the recall remedy on potentially affected vehicles.

## **Description of Remedy:**

Description of Remedy Program: Dealers will inspect the tonneau cover on the vehicle. If the tonneau is the recalled hard tri-fold tonneau, the dealer will replace the tonneau rails and clamps, and add a tether to prevent the tonneau from detaching onto the roadway even if improperly installed. If the tonneau is the recalled soft tri-fold tonneau, the dealer will provide the owner with improved instructions and additional labeling on the tonneau cover to facilitate proper installation, and a tether kit to retain the cover if it should be improperly installed.

Pursuant to 577.11, GM will provide reimbursement to owners for repairs

according to the plan submitted on May 12, 2021.

How Remedy Component Differs The new attachment configuration for the hard tri-fold tonneau cover from Recalled Component: resists loosening while driving, and the tether kit prevents an incorrectly installed tonneau from detaching onto the roadway. New soft tri-fold tonneau covers contain improved instructions and component labelling to clarify proper installation, and the tether kit prevents an incorrectly installed tonneau from detaching onto the roadway.
