Chronology:

- On August 28, 2020, the FCA US LLC ("FCA US") Vehicle Safety and Regulatory Compliance ("VSRC") organization opened an investigation based on information from the FCA US Chassis Engineering group of a potential noncompliance for the rear brake hose assembly on 2019 and 2020 MY Ram 4500/5500 cab chassis vehicles.
- On September 23, 2020, the FCA US VSRC organization confirmed that rear brake hose assemblies may have been built with an orifice diameter that is out of specification.
- On October 15, 2020, FCA US determined, through the Vehicle Regulations Committee, to conduct a voluntary safety recall of the affected units.
- On October 22, 2020, FCA US filed a Noncompliance Information Report pursuant to 49 CFR Part 573 which was assigned NHTSA recall number 20E-080 and FCA US Recall Number W76.
- On November 13, 2020, FCA US petitioned the NHTSA, pursuant to 49 CFR Part 556, for exemption from the notification and remedy requirements.
- On October 5, 2022, FCA US received notice that the NHTSA denied FCA US' petition.

Description of Remedy:

Description of Remedy Program: FCA US will conduct a voluntary safety recall on rear brake hoses. If installed on a vehicle, FCA US will remove the affected hose and install a new hose. If not installed on a vehicle, FCA US will inspect the production date label to determine if the hose is affected and replace if needed.

> FCA US has a longstanding policy and practice of reimbursing owners who have incurred the cost of repairing a problem that subsequently becomes the subject of a field action. To ensure consistency, FCA US, as part of the owner letter, will request that customers send the original receipt and/or other adequate proof of payment to the company for confirmation of the expense.
