Subject: 275/70R22.5 Goodyear G159 Recall (NHTSA Recall No. 22T009)

The Goodyear Tire & Rubber Company is offering to replace any 275/70R22.5 G159 tires manufactured between 1996 and 2003, which are described in the "Tires Involved in Recall" section below ("Subject Tires"). The Subject Tires installed on recreational vehicles may present an unreasonable safety risk due to tread separations and similar failure modes resulting from conditions present in RV use—which may include overloading and/or insufficient tire inflation pressure—that could affect vehicle control. Goodyear will replace the Subject Tires free of charge.

We request your assistance in handling customers who may present a Subject Tire. Dealers will receive full credit for each qualifying tire(s) returned. In addition, dealers will receive reimbursement for tire inspection, mounting, balancing, and handling costs.

Tire Inspection and Recall Handling Procedure:

When a customer arrives at your location, please follow the procedure below.

- 1. Verify that the tire size, type, DOT numbers match the "Tires Involved in Recall" as described above.
- 2. Deflate the tire.
- 3. Remove the tire/wheel assembly from the vehicle and then demount the tire from the wheel following standard practices.
- 4. Any tire covered by this recall should be promptly and permanently altered so that it is rendered unsuitable for resale for installation on motor vehicles. Examples of how to alter the tires include, but are not limited to: drill three ½ inch size holes in the sidewall above the TIN (DOT).

Replacement tires can be ordered using your normal tire ordering process.

To underscore the importance of maintaining proper load and inflation pressure, Goodyear also will provide the end user with a \$60 voucher that can be used to cover the cost of having their recreational vehicle professionally weighed. End user contact information **MUST** be included on the adjustment claim form under the **Consumer Information** section in order for Goodyear to send the \$60 voucher.

- Attach a copy of the no-charge service invoice, complete a Product Adjustment Claim form according to the instructions with the form. In the Removal Reason Box record "G159 Recall".
- Return recalled tires to your Product Service Center with your next shipment of adjustments. Follow the usual adjustment tire return procedures. See Product Service Bulletin 2021-01A, in the Product Service section on Tire-HQ, for adjustment return procedures.
