

## IMPORTANT SAFETY RECALL

August 30th, 2022

### NHTSA Recall Campaign No. 22T013

Dear Customer,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Antares Tire has decided that certain tires Comfort A5 fail to comply with the requirements of Federal Motor Vehicle Safety Standard (FMVSS) number 139, "New Pneumatic Radial Tires for Light Vehicles." These tires may experience belt separation around the tread pattern while driving increasing the risk of a crash. The defect that relates to motor vehicle safety may exist in one size of the Comfort A5 LT265/75R16 123/120S 10PR, that was manufactured between the 38th and 45th week of 2015.

We have determined that this issue may affect the performance of the tires in the range described below. Vehicle operators may see a bulge on the tread pattern if the tire is affected by this issue, and if the tire(s) is continuously used, the enlarging bulge may be easily noticed visually. As a result, Antares Tire is recalling all tires within the size and serial number ranges shown below.

Details of the recalled tires are as follows and the tire serial numbers can be found after the letters "DOT" on the tire sidewall. Antares Tire is recalling approximately these tires and DOT range is from 3815 to 4515 in the United States. Only tires manufactured during the period of time mentioned above are involved in this campaign.

You are receiving this letter because our records indicate that you are the potential owner of the affected tire that is the subject of this tire recall campaign. To ensure

your safety and satisfaction with our product, we request that you return any recalled tires and this letter to your Antares Tires dealer where you purchased the tire(s) as soon as possible. If the dealer's inspection verifies that you have a tire or tires within the affected range, the tire or tires will be replaced, mounted and, if needed, balanced at no charge to you, as long as you have presented them for remedy through Feb 28th, 2023 with receipt of this letter. If Antares replacement tires are not available at the time of inspection, the affected tire(s) will be replaced by another comparable tire brand using the same size and load rating as required by the vehicle manufacturer. After Feb 28th, 2023, tires will be replaced at a pro-rated value determined by remaining tread depth.

It will take just a few minutes to determine if your tire(s) is subject to the recall and approximately thirty(30) minutes per tire if replacement if required. The replacement will be performed at no cost to you.

If you had your tires replaced before you received this letter due to the issue described above, you may be eligible to receive reimbursement for the reasonable cost of obtaining a pre-notification remedy of the problem associated with this recall.
