Description of the Defect :	The manufacturing plant did not seal the panel, which isolates the furnace from the cooktop resulting in an inverted cooktop flame.

Description of the Safety Risk :	Without the cooktop being isolated from the furnace may cause negative air pressure, resulting in an inverted cooktop flame, which leads to potentially causing the propane supply line to fail, which may lead to property damage or personal injury.
Description of the Cause :	The manufacturing plant did not seal the panel, which isolates the furnace from the cooktop.

A routine Corporate Quality Control Audit discovered the issue in manufacturing, on October 1, 2021. On October 8, 2021, the manufacturing plant contacted OCC and an investigation was opened into this concern. On October 20, 2021, OCC and the manufacturing plant were able to isolate and identify vehicles involved.

On January 5, 2022, Forest River was made aware of additional vehicles that where manufactured before the original scope date of 21V828. OCC and the manufacturing plant then investigated further and found
