This is to inform you that your vehicle may be non-compliant with the requirements of the *Motor Vehicle Safety Regulations* and that the non-compliance could affect the safety of a person.

DEFECT/NONCOMPLIANCE:

The Federal Placard had the incorrect rim designated as 16X6J whereas the rim should be designated as 16X7J.

A tire may not seat at the bead if the consumer installs a 16x6J wheel, increasing the risk of a crash.

SERVICE PROCEDURE:

Dealership Service Department Service procedures for addressing the new federal placard are included with this notification, as well as the corrected Federal Placard to be installed. Federal Placard Installation:

- > The labels are located on the road side of the unit, low on the sidewall or on the upper deck on the same side and on the entry door;
- > Wipe off the labels with isopropyl alcohol;
- > Match the labels and carefully place the new labels directly on top of the old labels
