### Description of Defect :

**Description of the Defect :** Previously, KTM announced a recall (21V678) to inspect the retaining "R" clips on the front brake caliper.

On affected motorcycles, there is a possibility that the brake pad retaining "R" clip on the front brake caliper were mounted incorrectly and must be replaced. If the brake pad retaining "R" clips on the front brake caliper is mounted incorrectly there is a possibility the clips can unfasten and fall out and get lost while riding.

Description of the Safety Risk : On affected motorcycles, loosened or detached front brake pads can reduce braking performance, increasing the risk of a crash or injury.

It is mandatory to discontinue riding the motorcycle until the defect has been repaired.

Description of the Cause : Brake pad retaining "R" clips on the front brake caliper may be mounted incorrectly by the manufacturer.

## Chronology :

May 1, 2021, a field report in Europe was reported to KTM AG Customer Service indicating a possible issue related to a clip on the front brake caliper. In July 2021, J. JUAN SA advised KTM AG QC that it had reworked its stock, and all parts allocated to KTM AG were subsequently checked. KTM AG determined in July of 2021 that the brake pad retaining "R" clips on the front brake caliper may be mounted incorrectly and must be checked for proper mounting and a recall of the affected population was needed.

Component manufacturer J. JUAN SA continued product development and improvement following the July determination of incorrect installation of the retaining "R" clip. On November 3, 2021, a newly redesigned retaining "R" clip was made available by J. JUAN SA that has an additional retaining mechanism. November 2021, KTM AG determines the retaining "R" clips on the front and rear brakes should be replaced to maintain

continuity of components.

## Description of Remedy :

**Description of Remedy Program :** Husqvarna North America will notify its Husqvarna motorcycle dealers and customers about the campaign details via internet and owner letter respectively. Authorized dealers will complete the remedy free of charge to Husqvarna owners and on affected motorcycles in their dealer stock prior to delivery to retail customers. Dealer technicians will replace the brake pad retaining "R" clips on the front and rear brake caliper. If the motorcycle has been retailed to a consumer, authorized dealer technicians will replace the brake pad retaining "R" clips on the front and rear brake caliper. Husqvarna owners who previously had this inspection and replacement made will be offered a refund upon providing evidence of the same.

**How Remedy Component Differs from Recalled Component :** This new recall is to replace the originally mounted retaining "R" clips with new version "R" clips that has an additional retaining mechanism. We are also replacing the retaining "R" clips on the rear brake caliper for consistency on the motorcycle. This is to prevent the mixing up of retaining "R" clips by equipping the motorcycle with like clips on both the front brake and rear brake caliper.

**Identify How/When Recall Condition was Corrected in Production :** The new clip is being used in the assembly process.

**Description of Recall Schedule :** Husqvarna Motorcycles North America is notifying all registered owners of the affected motorcycles by mail and all authorized dealers via Husqvarna Dealernet, an internet-based communication portal. If an owner has previously paid for a repair related to this concern, they may request reimbursement by contacting Husqvarna Motorcycles Customer Relations.
