IMPORTANT SAFETY RECALL: 22V-020

CUMMINS ISX12 FUEL TUBE

This notice applies to your vehicle VIN: X

UNIT: 1xxxxx

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Ferrara Fire has decided that a defect which relates to motor vehicle safety exists in certain models of the following emergency vehicles manufactured April 2019 to November 2021, equipped with CUMMINS ISX12 FUEL TUBE:

Ferrara Fire - 2019-2021 INFERNO, 2019-2021 IGNITER, 2019-2021 CINDER

WHY IS A RECALL BEING CONDUCTED?

The fuel tubes between the fuel rail and the injector for cylinders 4, 5 and 6 may be susceptible to cracking, resulting in a high pressure fuel leak. A high pressure fuel leak in the presence of an ignition source may increase the risk of a fire. Fuel leaks may be detected during maintenance. An operator may smell fuel or observe a mist due to the fuel leak. The subject fuel tubes (for cylinders 4, 5 and 6) are susceptible to cracking due to metal fatigue resulting from a combination of vibration strain, assembly strain and material strength.

The affected item is the CUMMINS ISX12 FUEL TUBE.

WHAT ARE WE DOING ABOUT THE PROBLEM?

The subject fuel tubes for cylinders 4, 5 and 6 (the rear half of the engine) will be replaced with new fuel tubes (having the same part number as the recalled components) and vibration isolators will be added to the fuel tubes. A recall-specific reimbursement plan will be provided on the Recall Portal for those units not covered by the manufacturer's limited warranty. There is no cost to owners for this recall.

Vehicles subject to this recall are to be inspected and repaired by a Cummins Dealer. Cummins will inspect and install new components, provided free of charge if it affected. The estimated repair time will be 2 hours.
