Dear Grand Design RV Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Grand Design RV has decided that a defect which relates to motor vehicle safety exists in certain 2020-2021 Imagine recreational vehicles.

#### ! IMPORTANT!

- > Your vehicle falls within the recall population.
- You should immediately schedule an appointment with your dealer to have your vehicle repaired.

## Why is a recall being conducted?

On select 2020-2021 Imagine Travel Trailers manufactured between June 3, 2019, and March 24, 2021, the cast aluminum handles on the cabinet doors and drawers incorporate sharp edged corners in their design that may cause personal injury in the event forceful contact is made.

## What are we doing about the problem?

On affected vehicles, dealers will replace the square edged aluminum handles with new door and drawer handles that have a rounded profile. Grand Design dealers have been notified of this recall and have the required repair instructions available. Repair time is estimated to take no more than 1.5 hours. There will be no charge for this service through your Grand Design dealership.

#### What should you do?

Contact your selling or nearest Grand Design RV dealer as soon as possible to schedule an appointment. If your distance from a Grand Design dealer is significant, please contact us at 574-825-9679 and choose the "Recall" prompt or email <a href="mailto:recall@granddesignrv.com">recall@granddesignrv.com</a> We can discuss other arrangements to have the needed repairs completed.

## What if I no longer own this recreational vehicle?
