Description of the Defect : Sailun Tire of America decided that a defect which relates to motor vehicle safety exists in certain Sailun Specialty Trailer (ST) branded tires. In particular, the ST235/80R16 and the ST235/85R16 manufactured at Sailun's Vietnam plant (1YJ) from the 20th week of 2020 through the 41st week of 2020 are being voluntarily recalled.

Description of the Safety Risk : The defect is associated with a steel belt package design change that could contribute to a tread belt separation or tread delamination, increasing the risk of a crash.

Description of the Cause : The steel belt package design.

1/14/2022 – Tire Supplier of the recall issued by Sailun Tire Americas notified Keystone of an issue that exists with certain Sailun brand tires, Sailun Tire NHTSA Recall Number 21T-018. Investigation opened to research internal tire Identification Number (TIN) records.

1/26/2022 – Investigation of TIN records concluded. Scope and Range complete for pass through recall.

Description of Remedy :

Description of Remedy Program : The remedy is to inspect the tires DOT code and contact Sailun Tire Americas if the DOT codes fall under the recall range. Manufacturer Reimbursement Plan on file as of 10/07/2020. General reimbursement plan to be updated every two years. New vehicles are covered under warranty.

How Remedy Component Differs from Recalled Component : ST235/80R16G Sailun Tires within the listed DOT 1YJ and the last four digits of the DOT code 2020 to 4120 are in the affected range. If the factory code is MW, the tire(s) are not affected and no further action is required.

Identify How/When Recall Condition was Corrected in Production : All vehicles with affected tires were shipped prior to notification being received by Keystone RV.

Description of Recall Schedule : Keystone will notify the dealers and owners of the recreational vehicles by letter. A final copy of the owner letter will be provided to NHTSA, along with the dealer repair procedures.
