Dear Tiffin Motorhome Owner or Dealer,

For US Owners: This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. **For Canadian Owners:** This notice is sent to you in accordance with the requirements of the *Motor Vehicle Safety Act*. This is to inform you that your vehicle may contain a defect that could affect the safety of a person.

Tiffin Motorhomes has decided that a defect, which relates to motor vehicle safety, exists on the following models of motorhomes: **2020, 2021 & 2022 Allegro RED 360 37PA built between May 2, 2019 and January 4, 2022 that are equipped with a certain brand of sidewall mounted patio awnings.**

Tiffin Motorhomes has become aware of the possibility that certain sidewall mounted patio awnings may not be securely fastened to the motorhome. If the awning is not securely attached, there is the possibility that it may detach from the sidewall of the motorhome and this could lead to an accident or a personal injury.

Tiffin Motorhomes will have the awnings inspected to verify that they are correctly installed and then correct the installation if needed. Please arrange to take your motorhome to a **reputable service center OR dealer of your choice** to have the inspection completed. The recall inspection will take approximately 30 minutes and will be completed at no charge to you, the owner. If the awnings are not securely attached to the motorhome and repair is needed, please allow up to one hour for the repair.

On some 2020 models of 37PA Allegro RED's, the patio awning that is installed is a Dometic Brand awning that has a different method of attachment. If your motorhome is equipped with a Dometic Brand awning, there is no work to be done. Please contact Tiffin Motorhomes by phone at 256-356-8661 extension 2176 or by email at recalls@tiffinmotorhomes.com with your name and VIN so that we can clear the recall from your motorhome.

If you are using a service center that is not a Tiffin Motorhomes authorized repair facility, please make sure that they contact Tiffin Motorhomes for the required instructions and time allowed for the repair. Tiffin Motorhomes will not pay over the allowed time unless the repair facility receives a prior authorization. For authorization, contact Tiffin Motorhomes at 256-356-0261 or service@tiffinmotorhomes.com

You may be liable for any progressive damage that results from your failure to complete the recall within a reasonable time after receiving notification.

If you do not own the vehicle that corresponds to the vehicle identification number which appears on this Recall Notification, please return the notification to the Tiffin Warranty Department with any information you can furnish that will assist us in locating the present owner.
