This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai has decided that a defect, which relates to motor vehicle safety, exists in certain 2017 – 2018 Santa Fe Sport, 2016 – 2018 Santa Fe, 2019 Santa Fe XL, and 2014 – 2015 Tucson vehicles. Your vehicle, with the VIN shown above is among the impacted vehicles. Hyundai is initiating a safety recall to repair a condition involving the ABS modules in these vehicles in the U.S. and Canada.

The purpose of this letter is to explain what the recall is about and to keep you informed of Hyundai's recall implementation plan. We are currently preparing to implement the safety recall remedy which when available, will be performed at no cost to you. We will send you another notification when the remedy is available.

What is the problem?

The subject vehicles are equipped with Anti-Lock Brake System ("ABS") modules that could malfunction internally and cause an electrical short. An electrical short could result in an engine compartment fire while parked or driving.

What should you do in the interim?

We appreciate your patience. Hyundai is currently preparing to implement the recall remedy. You will receive a second notification letter when the remedy is available. Owners are strongly recommended to park their vehicles outside and away from structures until recall remedy is completed. For updated information regarding this recall, please visit:
