### IMPORTANT SAFETY RECALL – NHTSA Recall No. 22V-081

# This notice applies to Your Lamborghini Huracan with the VIN

Dear Lamborghini Owner or Lessee,

Automobili Lamborghini America LLC

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that certain Model Year 2015-2020 Huracan vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) number 108, "Lamps, Reflective Devices and Associated Equipment" Our records indicate that you are the owner of a vehicle in this recall.

#### What is the issue?

It has been determined that due to a human error, the blanking caps over the lower beam headlight horizontal adjustment screws were not installed on the subject vehicles.

Improper horizontal aim adjustment of the lower beam headlights is possible due to the absence of the blanking caps over the beam headlight horizontal adjustment screws. The customers can reach the horizontal adjustment screws and make improper horizontal adjustment by themselves.

Improper headlight horizontal aim may result in glare to others on the road, motorists/road users, reduced visibility on one of the sides of the road, and reduced down-road visibility. All these scenarios can increase the risk of a crash.

For all the reasons set forth above, it is therefore necessary to repair these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

# What Do You Need to Do?

Please contact your preferred authorized Lamborghini dealer immediately to schedule an appointment to have this important repair performed, free of charge.

#### What will Lamborghini do?

We will install the missing blanking caps free of charge. The repair could take up to 30 minutes. We apologize for any inconvenience this recall may cause.

Please bring this letter and your Service Booklet with you when you visit the dealer, so that the dealer can make all necessary entries.

If you have previously paid for a repair related to this condition, you may be eligible for reimbursement. Please contact Lamborghini Customer Care at the number below for details on how to claim for reimbursement.

#### What if you are not the current owner of this vehicle?

You can update your vehicle ownership or contact information by filling out the enclosed document (Appendix A) and sending it to Lamborghini by following the instructions.

If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within ten days.
