determined that on certain Mercedes-Benz VS20 Metris vehicles (platform 447), a hardware defect in a memory chip within the rear view camera may

cause the camera image in the rear view display to freeze.

Description of Remedy Program: An authorized Mercedes-Benz Metris dealer will replace the rear view

camera on the affected vehicles. As an intermediate solution an authorized Mercedes-Benz Metris dealer will conduct a Software Update on the affected vehicles to significantly lower the probability of failure

occurrence. In case of failure occurrence, the software update would also lead to a black screen instead of frozen image to further mitigate the safety

risk until sufficient numbers of spare parts are available.

Pursuant to 49 C.F.R. § 577.11(e), Daimler Vans does plan to provide notice about pre-notice reimbursement to owners since all involved vehicles are no longer covered under the new vehicle warranty.
