This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2022 Connect, Sonic, SportTrek, and Stratus trailers. As a result, KZRV is conducting a safety recall. **Reason for
this recall**

The vehicles subject to this recall were built with a defective coupler. This coupler may have missing or incomplete welds which may cause the trailer to separate from the tow vehicle and could result in a crash resulting in property damage, personal injury, or death.

**What we
will do**

The remedy is to inspect the coupler and replace if necessary. The repair should take approximately 1 hour to complete. This repair will be done at no cost to you.

**What we need
you to do**

You should contact your selling dealer to have your vehicle inspected and if needed to have the defect repaired in your vehicle.
